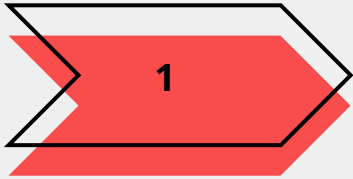

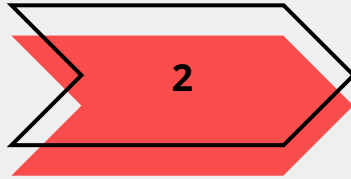

Certain rules of the French Labour Code and collective agreement apply to seconded staff. Are you hiring your first employee in France ?

You are a foreign firm with no business premises in France but hiring staff here. Your staff must be registered with the French social security regime. You will need to produce pay slips and pay contributions to the relevant social security organisations.
